EVENT OF AMATEUR COLLECTORS MARKET

(declaration in lieu of affidavit - ex art. 41.4/1/68 15) the undersigned declares

Pursuant to and purposes of art. 4 of Law No 4 January 1968 15 , declare under his/her own responsibility:

- To participate in the event of amateur collectors market in quality of private exhibitor .

- Not to carry out trading activities in a personal manner , but only occasionally , in times of such events , exchanging or selling items deriving exclusively from personal property

- To exchange or sell only non-precious objects , devoid of archeological or historical interest and antiquary under Law November 20 1971 n. 1062 . During the course of the demonstrations are permitted exchange and trading of the items and materials exposed by the participants .
